## MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding (MoU) is entered into between 1 Assam Bn NCC, BBK College Unit, represented by Capt. Jakir Hussain, ANO hereinafter referred to as "BBK College Unit," and 60 Assam Girls Bn NCC, Bapujee College Unit, represented by ANO, hereinafter referred to as the "Bapujee College Unit," with the aim of fostering collaboration and cooperation between the two National Cadet Corps (NCC) units for the promotion of mutual objectives and activities.

### Objective:

The objective of this MoU is to establish a partnership between BBK College Unit and Bapujee College Unit of the NCC for promoting camaraderie, exchange of ideas, and joint initiatives aimed at enhancing the overall development of cadets and fostering a spirit of patriotism, discipline, and leadership.

### Terms of Agreement:


#### Joint Training Activities:

BBK College Unit and Bapujee College Unit agree to organize joint training programs, camps, workshops, and seminars for the benefit of cadets from both units. These activities may include leadership development, skill enhancement, adventure training, and community service projects, among others.

#### Inter-Unit Competitions:

Both parties shall collaborate to organize inter-unit competitions and events, such as drill competitions, sports tournaments, cultural festivals, and academic quizzes, to foster healthy competition and camaraderie among cadets from BBK College Unit and Bapujee College Unit.

Collaborative Projects: BBK College Unit and Bapuji College Unit may collaborate on special projects and initiatives aimed at serving the community, promoting social welfare, and contributing to national development goals. Such projects may include cleanliness drives, blood donation camps, environmental conservation efforts, and disaster relief activities.


