### 1) Duration /Term of Agreement

The validity of the Agreement only between 06/05/2023 to 31/12/2025 for any skill development project.

### 2) General Term & conditions :

- I) That this appointment as service provider has own center at **Bapujee College**.
- II) That the second party would be entitled to enroll number of candidates as per approved number for each program (Job roles) and allocated to centre of first party for the respective training.
- III) The second party/service provider will pay the maintenance charge, Electricity charges and payment, Furniture of the same to be made in time for maintaining the course duration.
