**MEMORANDUM OF UNDERSTANDING**

New Horizon, MRD Road , Bamunimadam, Guwahati, 781021 2<sup>nd</sup> Party represented by Amit Kakati.

The expression of both the parties wherever they occur in the body of this MOU shall mean and include their respective heirs, executors and administrators.

**NOW THIS MOU IS MADE AS HEREUNDER:-**

1.1 WHEREAS the First Party is the Principal of Bapujee College, Sarukshetri , P.O- Sarthebari, Barpeta, Assam-782123 that the college, has the required infrastructure for conducting few batches of skill training simultaneously in an area of 2000 sq. ft. approximately in their premises.

2 WHEREAS the Second Party New Horizon has approached the 1<sup>st</sup> party College for giving them Infrastructure on hiring basis to conduct training courses in the premises measuring 2000 sq. ft. approximately for Skill Development of Youth, Women and Entrepreneurs etc. under the 100% funding Schemes of Both Central and State Government by utilizing training related infrastructure belonging to the Bapujee College, Sarukshetri like Training Hall, Training Lab, etc.

**AND WHEREAS** the First Party has agreed to the proposal and now the present Witness and Parties mutually agree as follows:

That the First Party has agreed to give, and the Second Party has agreed to utilize the facilities on the above mentioned Premises from 10/01/2023 initially for a period of 15 (fifteen) months up to 30/01/2024 extendable for further period upon mutual understanding depending on the prevailing situation and conditions.

That the Second Party has agreed to pay the hiring charges to First Party as follows:-

- 1) The charge for building accommodation, training infrastructure will be 80% of funds received for per trained, certified and placed candidates.

Makeup Artist per candidate- 9200/- (80% of received fund)

Field technician computing & Peripherals per candidate - 11700/- (80% of received fund) The payment will be made by the Second Party in three parts after receiving the bill from the concern Department, within seven working days.

- a) 1<sup>st</sup> installment 30% will be paid after 35 days of batch start.
- b) 2<sup>nd</sup> installment 40% will be paid after the certification and placement of all certified candidates.
- c) 3<sup>rd</sup> installment 30% will be paid after 3 month of post placement taking of all certified candidates..

The First Party has agreed to the following:-

- 1) SMART Accreditation Fees: Rs.37,000/- (refundable)
- 2) Equipment price for Makeup Artist job role Rs. 39300/-
- 3) Equipment price for FTCP job role Rs. 38800/-
- 4) To pay the Municipality Tax, Land Revenue and Other Taxes in force.
- 5) Arrange Water Supply.
- 6) To arrange Electricity including power backup.
- 7) Regular maintenance of the building and infrastructure.

3. Other terms & conditions:-

i. It is agreed between the parties that if any damage is caused during the training period the necessary expenditure shall be bear by the 2nd party for the repairs & replacement of damaged items to the College as assets being used by the 2nd party.

ii. The 1<sup>st</sup> party will provide required parking space in the campus measuring around 1500 sq. ft.

iii. This MOU will be revocable by either Party by giving prior notice of 1 (One) month to the other if so required under any circumstances.
